

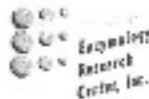

Terms and Conditions of Sale

The Terms and Conditions of Sale set forth below, unless modified in writing by Equinoxity between Seller and Customer, notwithstanding any conflicting term(s) or condition(s) of Customer or communication to the contrary, Customer is the party purchasing product, services or format of any conflict between these Terms and Conditions of Sale and any other documents or oral Seller and Customer are herein each a "party" and collectively are the "parties."

- 1. Terms of Sale.** Customer's order specified on purchase order hereof with respect to products to be developed or supplied (the "Article" or "Articles") shall be governed by these terms and any purchase order or other document or communication shall in any way modify these Terms and Conditions expressly objected to and rejected by Seller. Customer shall be deemed to have accepted Terms and Conditions, except as set forth herein, in sales order form.
- 2. Payment.** The standard products ordered by pre-approved credit applicants, terms of payment are specifically approved by Seller in writing. Seller may require a completed credit application prior to Seller's sole discretion, Seller will not be required to perform or undertake any work until and as with the 11th day after the invoice is due. In addition to interest at a rate of 1.5% per month, such is an amount by law, whichever is lower, interest shall accrue monthly. Both the one-time administrative fees per invoice. Returned checks may be submitted for collection and are subject to a \$50 return fee (see specific terms sheet) and one and all discounts given. Customer shall pay all of Seller's credit collection costs incurred to collect any amounts owing Seller.
- 3. Shipping.** Orders otherwise agreed upon in writing, all Articles will be suitably packed for shipment or for carrier agent, FOB Seller's shipping dock in Allenton, MN, with passage of title occurring as necessary. Seller shall invoice Customer each week packaging. The price invoiced to the Customer including customer's used by the Seller. Customer shall verify correct weight, insurance, and other special packing expenses shall be paid by Customer.
- 4. Risk of Loss and Delivery.** Seller is liable for loss or damage subject to Customer upon delivery to its loss that occurs during shipment and to the extent Customer accepts the Article. If Seller receives more than 10 days after the shipment date, a 40% restocking charge will be assessed on all reshipments. Articles that have been further, unrespected, labeled, or incorporated into or a processed or contaminated, shall not be accepted for return. Customer will pay for all freight costs on Article, within 10 days of Article that fail to meet the warranty set forth herein are returned with packaging for Article not purchased within one or 2 months, Customer will be responsible for all shipping charges, which will be 10 days and returned with prior authorization. In no event will Seller be held liable for any damage or loss by Customer or its agents. No credit may be taken by Customer sufficient credit for any Article that have been destroyed or abandoned by Customer. Seller will warehouse over 90 days.
